- By completing and signing this application for credit, applicant expressly authorizes Precision Limousine, Inc . ("PRECISION") to obtain employment, credit and other such information as it may deem necessary in connection with the application made herein. Full payment shall be due within 10 days of receipt of statement. Failure to make payment in full by the due date, shall subject applicant's account to a LATE PAYMENT CHARGE, which shall be computed on the "average daily balance" at a monthly rate of 1 1/2 % (annual percentage rate of 18%). To get the "average daily balance" we take the beginning balance of your account each day and add any new charges, other adjustments and any unpaid late payment charges, and subtract any payments or credits. This gives us the daily balance. Then, we add up all the daily balances for the billing cycle and divide this total by the number of days in the billing cycle. This gives us the "average daily balance".
- In the event the account remains unpaid for more than 30 days, and in addition to any Late Penalty Charges, PRECISION shall have the right to utilize any lawful collection methods to secure full payment. In such event, applicant shall be liable for any and all expenses, including legal fees and costs, incurred by or on behalf of PRECISION in the collection of said monies.
